PUBLIC SELECTION PROCEDURE

In accordance with the management decision n. 314 of 23.5.2023 a selection based on an interview is open, for a full time 12 months fixed-term job, extendable until 31.12.2025, for the position of

NURSE

for all the structures of this ASST

Reserved for male and female healthcare personnel with a professional qualification obtained abroad in accordance to D.L. n. 18 of 17.3.2020 converted with amendments into Law 24.4.2020 n. 27 and of D.L. n.34 of 30.3.2023 who can temporarily practice the nursing profession.

In order to participate to the selection, applicants must have and prove at the time of submitting the application, the following requirements, on pain of exclusion.

REQUIREMENTS

GENERAL REQUIREMENTS:

- a) be no younger than 18 and not older than 60;
- b) have a physical fitness for employment; this must be full and unconditional with respect to the specific duties (direct assistance to patients in the hospital or in other outpatient settings, unassisted handling of non-self-sufficient/non-cooperative patients, including pulling and pushing trolleys, night shifts). Before starting work applicants will undergo a medical check-up to certify their physical fitness;
- c) be a non-european Union citizen, referred to D.L. n. 198/2022 converted with amendments into Law n. 14/2023 and D.L. 34/2023;

SPECIFIC REQUIREMENTS:

- a) Have a degree in nursing awarded by a foreign University and properly recognized by the Lombardy Region, according to article 13 of the D.L. n. 18/2020, converted with amendments into Law 24 April 2020, n. 27.
- b) Have at least a basic knowledge of italian language.

The following documents have to be submitted at the time of the application, on pain of exclusion:

- a. *a valid identity document (ID card or Passport);*
- b. *documents that prove the requirement referred to letter c) of the general requirements;*
- c. *documents that prove the requirement referred to letter a) of the specific requirements;*
- d. *certified copy of the degree in nursing and its traslation into italian;*
- e. *certificate of good health issued by a Medical Doctor.*

Applications must be submitted in italian and sent to the Human Resources office ONLY by email to the following cerified e-mail address: protocollo@pec.asst-settelaghi.it.
For that reason, applicants must use a certified e-mail address which they own or of another authorised person.
